AMERICAN INTERGOVERNMENTAL RELATIONS Introduction

This course centers around a discussion between instructor and class members on the origins and development of the continuing relationships between and among agencies of the federal government, the state governments and units of local government.

These intergovernmental relations (IGR) are fundamental to an understanding of governmental programs and issues, and governmental organization and structure in modern society. The objective of the course is to discern ways of improving governmental management mechanisms, policies and practices within the federal system. Because there are no pat answers to problems that arise between governments, class members are encouraged to participate fully in class discussion and in undertaking research that may point a direction for the resolution of a problem or issue in this context.

This is <u>definitely not</u> a lecture course. It is a joint discussion entered into between the instructor and class members, and among class members themselves. Hence, active participation is a requisite for the course.

Course Foundation:

The success of this course depends on adequate preparation and participation by class members and instructor alike. The building blocks of the course are:

Participation in Class Discussion

The field of intergovernmental relations (IGR) is forever changing, so much so that there are few experts who can talk to or write well on the intricate and complex issues involved. Since this is the case, it is doubly important that each and every class member will be assigned at the outset to discuss an assigned component of the theme (below). Do not wait for the instructor to lead the discussion—be a leader yourself.

Research Endeavor - Theme: "Improving the Intergovernmental Relations System"

The research endeavor is considered the cornerstone of this course and is weighted accordingly. This is not the usual term paper. All class members are invited to be highly innovative in their research on an assigned aspect of this theme. What is looked for are specifics involving two (2) or more jurisdictions at two (2) or more levels of governmental activity, or two (2) or more jurisdictions at the same level of activity.

The by-product of the research is submission of a paper that addresses itself to the theme assignment. The length of the paper will not be a factor in the final grade. Instead, the quality of the research and the reporting of it will be considered as one, and a grade will be given, based on these factors:

- (a) quality of the research itself--has the class member been thorough in looking at the issue/problem/relationship?
- (b) the depths of the research-does the paper reflect the amount of research necessary to bring about a completed project?
- (c) quality of innovation--what are the results attained? What new research techniques are exhibited?
- (d) orderly presentation of material--is there a logical buildup of the material so as to leave little doubt about the conclusions arrived at by the preparer?

Class members are at liberty in introducing their own style of writing, including footnoting, providing that the style is consistent throughout the paper. Members who intend to do more writing as time passes are encouraged to utilize a more standard reporting style. One acknowledged guide is: Turabian, Kate L., A Manual for Writers of Term Papers, Theses, and Dissertations, University of Chicago Press, Chicago, 1955. Other style guides are available and can be used.

Class members are urged to adhere to the following timetable for their research paper:

- 1. Selection of topic and submission of paper outline....4th class
- 3. Submission of final paper--(original and one copy)....No later than class prior to final exam.

Final Examination

There will be a final examination, held on the last day of class. Examination questions will be based entirely on material provided in the required texts for the course. Caveat--Keep up with your required readings.

The instructor will review important materials during the last class session prior to final examination.

Instructor's Caveat

The instructor finds the combination of both texts to be suitable coverage of the field of intergovernmental relations (IGR). The last comprehensive text in the field was written by W. Brooke Graves under the title of American Intergovernmental Relations in 1964. It is still an excellent reference work. However, since so much has transpired since 1964 in intergovernmental relations, it is dated and out of print. In addition, much of the current available material written in this field lacks the comprehensiveness of the Graves' work.

Due to the ever-changing nature of intergovernmental relations, it is difficult at any one time to capture a solid body of knowledge within the covers of a single text.

The publications suggested for this course together cover the field in a fairly comprehensive manner and they do target in on many of the critical areas.

The syllabus attempts to suggest additional readings to class members.

In terms of a single source of information, the many reports of the U.S. Advisory Commission on Intergovernmental Relations (Washington, D.C. 20575) should be referenced. Normally, individual copies of reports can be secured without charge directly from the Commission.

The instructor lends a willing ear to any and all recommendations of better texts.
