The upcoming season will be a busy one for students of federalism. The annual meeting of the American Political Science Association (APSA) in Boston, Massachusetts, from August 28 to September 1, 2002, will feature many panels on federalism. Please attend those panels if you go to the APSA meeting.

Switzerland will host a large International Conference on Federalism in St. Gallen on August 27-30, 2002, in

cooperation with the Forum of Federations. The conference will focus on three themes: (1) Federalism and Foreign Relations, (2) Federalism, Decentralization, and Conflict Management in Multicultural Societies, and (3) Assignment of Responsibilities and Fiscal Federalism.

The International Association of Centers for Federal Studies (IACFS) will hold its 2002 meeting at the Institute of Federalism in Innsbruck, Austria, on November 13-17, 2002, in cooperation with the Research Committee on Federalism and Federation of the International Political Science Association (IPSA). The conference theme is "The Homogeneity of Democracy, Rights, and the Rule of Law in Federal and Confederal Systems."

These activities reflect the continuing and growing interest in federalism worldwide and the role that federalism can play in democratization and rights protection. Of the world's 25 federal systems, for example, 76.0 percent are electoral democracies, compared to 60.8 percent of the world's other political systems. Seven of the world's eight territorially largest nations are democratic federal polities—Argentina, Australia, Brazil, Canada, India, Russia, and the United States of America.

Meyner Center Conducts 2002 Fulbright Institute on the U.S. Constitution

The Robert B. and Helen S. Meyner Center for the Study of State and Local Government conducted a six-week summer Fulbright American Studies Institute on “The United States Constitution: Origins, Evolution, and Contemporary Issues” for 18 scholars from 17 countries from every region of the world. The institute, funded by the Bureau of Educational and Cultural Affairs of the U.S. Department of State, was directed by John Kincaid. the Lt. Governor of New Mexico, with sightseeing at Rocky Mountain National Park, Garden of the Gods, Santa Fe, Taos, and other spots. The study tour ended in Washington, D.C., for sightseeing and meetings at the Council of State Governments, National Association of Attorneys General, and public officials.

Meyner Center Conducts 2002 NEH Institute on State Constitutions

The Meyner Center conducted a four-week institute from July 7 to August 2 for middle-school and high-school teachers in the United States on "History, Tradition, and Democratic Theory in American State Constitutions." The institute, held at Lafayette College, was funded by the National Endowment for the Humanities. The institute was directed by John Kincaid. J. Edwin Benton of the University of South Florida recently published *Counties as Service Delivery Agents* (Westport, CT: Praeger, 2002)

Earl H. Fry has been working recently on the impacts of globalization and rapid technological change on regional and local governments in federal systems. He was part of the Los Angeles-based Pacific Council on International Policy (PCIP) team and Ford Foundation-funded project that “mapped” globalization in Seattle, San Francisco, Los Angeles, San Diego, and Salt Lake City. He is the author of *Mapping Globalization Along the Wasatch Front* (PCIP, 2002), *The North American West in a Global Economy* (PCIP, 2002), and *The Expanding Role of State and Local Governments in U.S. Foreign Affairs* (Council on Foreign Relations, 1998). He is also co-convenor of the International Political Science Association's Research Committee on Globalization and Governance and will organize two panels at the plenary conference to be held June 29 - July 4, 2003, in Durban, South Africa. The panels will deal with (1) multi-level governance and (2) challenges to governance in an era of globalization. Earl will serve as the Enders Fellow in Canadian-American Relations at McGill University in Fall 2002 and will conduct research on the international activities of Canada's provinces and municipalities.

Rudolf Hrbek of the Europäisches Zentrum für Föderalismus-Forschung hosted an international conference on “Aussenpolitik von Regionen” in Karlsruhe, Germany, on June 20-22, 2002. Papers from the conference will be published next year.

Yasuhiro Katagiri of Tokai University, Japan, who was a participant in the Meyner Center's 1998 USIA Summer Institute on American Federal Democracy, was awarded the McLemore Prize by the Mississippi Historical Society in March 2002 for his new book, *The Mississippi State Sovereignty Commission: Civil Rights and States' Rights* (2001). His book is the first comprehensive history of the Mississippi State Sovereignty Commission, which was established in 1956 “to protect the sovereignty of the State of Mississippi... from encroachment thereon by the Federal Government.” The commission was originally hailed by many white Mississippians as a noble bastion of massive resistance to desegregation, but it eventually came to an unsavory end in 1973. Yasu made extensive use of the papers of the commission, which were finally unsealed and opened for examination in 1998. Mississippi, “the closed society,” as James Silver put it in 1964, lay at the heart of the white South's resistance to the civil-rights revolution, and the extensive records available on Mississippi's commission offer unique insights on the rise and fall of that resistance.

Abdul Aziz M. Shady, a participant in the Meyner Center's 2001 Fulbright Institute and member of the faculty at Cairo University, helped to host John Kincaid, Director of the Meyner Center, and Lucille D. Guarino on a Fulbright-sponsored lecture and consultation visit

to Egypt on March 28 - April 4, 2002. The principal purpose of the visit was discuss partnership plans for curriculum and research development at Cairo University's new American Studies Center. The outbreak of military hostilities between Israel and the Palestinians during the visit, however, generated sizable student demonstrations in Egypt, which, while complicating the lecture schedule, pointed up the need for better dialogue and understanding on all sides. Kincaid also met with Dr. Hala Mustafa, Head of the Democracy Research Unit at the Al Ahram Center for Political and Strategic Studies. A paper by John Kincaid and Richard L. Cole, "Terrorism and Federalism: Perspectives of Federalism Scholars," was later published in Arabic in the unit's journal *El Dymocrazia*.

A Global Dialogue on Federalism in the 21st Century: Practices, Perspectives, and Prospects

The Forum of Federations, based in Canada, and the International Association of Centers for Federal Studies (IACFS) have launched an exciting new, multi-year program entitled “A Global Dialogue on Federalism in the 21st Century: Practices, Perspectives, and Prospects.” The goal of the program is to create an international forum for practitioners, scholars, and youth to examine best practices and to produce valuable interactive and educational resources about current and emerging issues in federalism worldwide. This unique program will offer a comparative examination of a wide range of issues on federal governance and will also build the intellectual capital needed to enhance teaching and

research on comparative federalism throughout the world.

The Global Dialogue will be carried out through several hundred local workshops and international conferences, web-based discussions, and the publication of practical handbooks. Its aim is to create forums through which practitioners, scholars, and youth exchange experiences and academic research in order to identify lessons, best practices, and emerging challenges. The Global Dialogue further aims to produce comparative handbooks for worldwide distribution for use as practical reference guides and training tools by practitioners and students of federalism.

Themes

More than a dozen issues in federalism will be examined through this global dialogue. Approximately three theme processes will be initiated each year. The first themes to be launched during the next two years are:

- Constitutional Origins, Structure, and Change in Federal Democracies
- Foreign Relations in Federal Systems
- Distribution of Responsibilities in Federal Democracies
- Legislative and Executive Governance in Federal Democracies
- Parties, Interest Groups, and the Politics of Civil Society in Federal Democracies

The following themes are tentatively planned for development in subsequent years of the Global Dialogue:

- The Role of Local Governments in Federal Systems
- High Courts in Federal Democracies
- Intergovernmental Relations
- The Political Economy of Federal Democracies
- Federalism and Ethnic Conflict/Minority Nationalism
- Making and Unmaking Federalism Worldwide
- Debating the Theory and Practice of Federal Democracy

Each theme will be examined through a three-part process: (1) a series of country workshops and international conferences that provide in-person forums for discussion; (2) a cyber-based dialogue via an interactive website; and (3) a series of handbooks that will document and synthesize the lessons learned about current practices and emerging trends derived from the first two processes and from additional scholarly research. Each theme, and resulting handbook, will feature 10-12 federal polities representing established and newer federal countries, a representative sample of different institutional arrangements, common-law and civil-law federations, federal countries in the developed and developing worlds, and federal countries that offer interesting lessons or

variations relevant to the particular theme.

A Theme Coordinator will be chosen for each theme to plan and coordinate the theme process and to serve as the editor of and contributor to the resulting handbook. The Theme Coordinator will also organize two international conferences around the theme and handbook.

For each country featured in the theme, a country expert will be selected to serve as the Country Coordinator. This person will write the country chapter for the theme and also organize two country workshops around his or her country chapter.

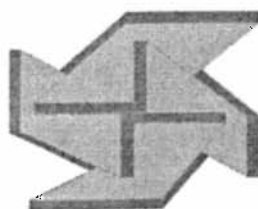
